A RECIPROCAL COURSE TO COURSE ATRICULATION AGREEMENT

Between

Saskatchewan Institute of Applied Science and Technology (SIAST)

And

Briercrest College and Seminary

This is a reciprocal transfer credit agreement which provides for recognition of selected courses completed by students at SIAST (Business Certificate Program) and at Briercrest College and Seminary.
